The Acting Secretary of Health appealed to the PA Supreme Court.

Stay of masking order granted until December 4th.

The Governor's office has filed an appeal to the PA Supreme Court.

Upon the expiration of the statewide mandate, local school officials will again be able to implement mitigation efforts at the local level.

WSSD will revert back to our Health and Safety Plan prior to the PA Health Secretary's Mask mandate.

We will present a revised Health and safety Plan on Dec. 13 for board consideration.


Thursday, November 25
